Established in 1883 as Minnesota Board of Medical Examiners Minnesota's first healthcare provider licensing board

## Mission of HPSP

Established in legislation in 1994 by Board of Medical Practice, Board of Nursing and Board of Pharmacy with Associations

Minnesota's Health Professionals Services Program protects the public by providing monitoring services to regulated health professionals whose illnesses <u>MAY</u> impact their ability to practice safely.

## Who are we?



(Minn. Stat, 214.32, Subd. 1)

## MN Statute 214.33 Reporting

**Subd. 1 Permission to report.** A person who has personal knowledge that a regulated person has the inability to practice with reasonable skill and safety by reason of illness, use of alcohol, drugs, chemicals or any other materials, or as a result of any mental, physical, or psychological condition may report that knowledge to the program or to the board.

\*A report to the program under this subdivision fulfills the reporting requirement contained in a regulated person's practice act.

## **Reporting Continued...**

#### 214.33 Sub. 4. Board

A board may refer any regulated person to the program consistent with section <u>214.32</u>, <u>subdivision 4</u>, if the board believes the regulated person will benefit and the public will be protected.

#### 214.34 Sub. 1. Immunity

Any individual, agency, institution, facility, business, or organization is immune from civil liability or criminal prosecution for submitting a report in good faith to the program under this section or for cooperating with an investigation of a report or with staff of the program. Reports are confidential and are privileged communication.

# What is Monitoring?

## **HPSP Process and Determination**

#### <u>Intake</u>

- Describe the program
- Provide Tennessen
- Obtain background information
- Determine initial plan

#### **Determine if monitoring is warranted**

- Diagnosis of a current illness or history of illness
- Active symptoms, triggers, and/or stressors
- Treating Provider recommendations
- History usually five years
- Profession and safety

\*HPSP staff does not complete assessments

- HPSP Team consult
- Medical consultant
- Follow up with treating providers
- Follow up with enrollee
